

**Contract for the Procurement of 1 Lot Maintenance of Document Management (Attache) System**

THIS AGREEMENT made on 02 October 2020 between the *ANTI-MONEY LAUNDERING COUNCIL* of the Philippines (hereinafter called "the Procuring Entity") of the one part and *MICROBASE, INC. and IDEYATECH, INC. (JOINT VENTURE)* with respective addresses at *CASMER BLDG, 195 SALCEDO ST., LEGASPI VILLAGE, MAKATI CITY* and *1005 WEST TOWER, PHILIPPINE STOCK EXCHANGE CENTER, EXCHANGE RD., ORTIGAS CENTER, PASIG CITY* (hereinafter called "the Supplier") of the other part:



WHEREAS the Procuring Entity invited Bids for certain goods and ancillary services, viz., *PR20-014: 1 Lot Maintenance of Document Management (Attache) System* and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *One Million and Nine Hundred Forty-Two Thousand Pesos (PhP 1,942,000.00)* (hereinafter called "the Contract Price").,

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

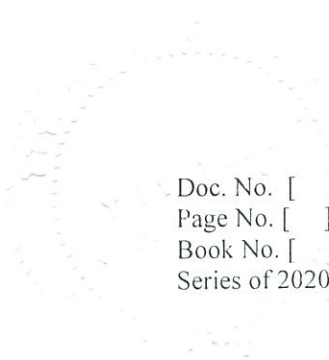
