WHEREAS, the Parties have an existing Consultancy Services Agreement, which will expire on 28 February 2023, for the delivery of services in relation to the Philippines' International Review Group (ICRG) Action Plan and exiting the Financial Action Task Force (FATF) Grey List;

WHEREAS, the services of the Consultant remains critical in guiding the AMLC and the relevant government agencies in meeting the Philippines' deliverables for the ICRG process, including for the implementation of the Action Plan, submission of reports for each cycle and meetings with the Asia Pacific Joint Group (APJG);

WHEREAS, there are at least three (3) remaining reporting cycles for the Philippines under the ICRG Process;

WHEREAS, the AMLC has authorized the procurement of the project "Procurement of Consultancy Services for International Cooperation Review Group (ICRG)" under Item No. 30 of the Amended Annual Procurement Plan (APP) and Item No. 37 of the Supplemental APP;

WHEREAS, the renewal of the Consultancy Services Agreement is authorized under Republic Act No. 9184 (Government Procurement Reform Act), its 2016 Implementing Rules and Regulations and Joint Circular No. 1, Series of 2017 issued by the Civil Service Commission, Commission on Audit and Department of Budget and Management (Rules and Regulations Governing Contract of Service and Job Order Workers in the Government);

1. Renewal of Contract

- 1.1. The Parties agree to renew the *Consultancy Services Agreement* under the same terms and conditions, with the necessary amendments as herein prescribed.

This Renewal Contract shall be valid for period of six (6) months starting 01 March 2023 and ends on 31 August 2023, renewable at the option of the AMLC, subject to the execution of another Agreement.
