

**Contract/Agreement for the Procurement of One Lot Oracle Database
Appliance with Oracle Database Enterprise Edition License**

CONTRACT/AGREEMENT

THIS AGREEMENT made this 15 DEC 2023 day of 2023 between the **ANTI-MONEY LAUNDERING COUNCIL** of the Philippines, represented by its Executive Director, Matthew M. David, with office address at Room 507, 5/F, EDPC Building, BSP Complex, Malate, Manila (hereinafter called "the Procuring Entity") of the one part and **RADENTA TECHNOLOGIES, INC.**, represented by its Authorized Representative, Ms. Jamaica E. Arcillas, with office address at U-2BC CBC Corporate Center 724 Shaw Blvd. Wack Wack Mandaluyong City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Procuring Entity invited Bids for certain goods and ancillary services, particularly **One Lot Oracle Database Appliance with Oracle Database Enterprise Edition License** and has accepted a Bid by the Supplier for the supply of those goods and ancillary services in the sum of **Fifteen Million Seven Hundred Thousand Pesos (PHP15,700,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents, as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184, shall be deemed to form and be read and construed as integral parts of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of *Fifteen Million Seven Hundred Thousand Pesos (PHP15,700,000.00)* or such other sums as may be ascertained, the **RADENTA TECHNOLOGIES, INC.** agrees to deliver and implement **PR No. 23-077: One Lot Oracle Database Appliance with Oracle Database Enterprise Edition License** in accordance with its Bid.
4. The **ANTI-MONEY LAUNDERING COUNCIL** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

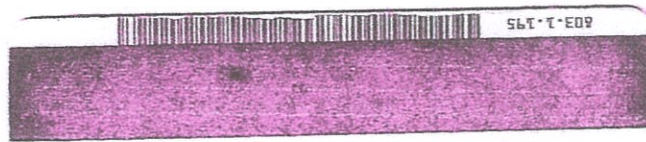

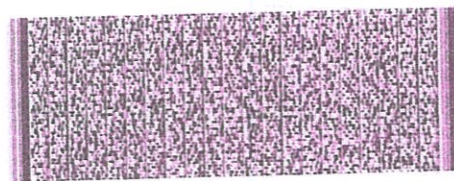


