### BRIEF DESCRIPTION

Catering services for the conduct of AMLC Year-End General Assembly to be held at the Bangko Sentral ng Pilipinas (BSP) Assembly Hall on 5 December 2023.

The Approved Budget for the Contract (ABC) is Five Hundred Fifty-Six Thousand Five Hundred Pesos (PhP556,500.00) plus 10% contingency of Fifty-Five Thousand Six Hundred Fifty Pesos (PhP55,650.00) or a total ABC of Six Hundred Twelve Thousand One Hundred Fifty Pesos (PhP612,150.00).

## GENERAL CONDITIONS

### *Quotation Price:*

Supplier's quotation shall be inclusive of all costs, applicable taxes, charges and other incidental expenses, including, but not limited to notarial expenses.

### *Quotation Validity Period:*

Quotations shall be valid for thirty (30) calendar days from receipt by the BAC Secretariat.

### *Delivery Period/Completion Period/Contract Period:*

Delivery period shall be on 5 December 2023 from 3:30PM to 7:30PM.

### *Liquidated Damages:*

- A delay by the Supplier in the full delivery of the goods/services shall render the Supplier liable for liquidated damages, which shall be deducted by the AMLC from each payment or total contract price in case of one-time payment.
- Liquidated damages shall be equal to one-tenth (1/10) of one percent (1%) of the total contract price for every day of delay.

### *Payment:*

- Payments shall be made only upon the issuance of the **Inspection and Acceptance Report (IAR)** by the IAC.
- No payment shall be made for supplies and materials not yet delivered or services not yet rendered.
- The Supplier's request for payment shall be made in writing, accompanied by an invoice describing, as appropriate, the goods delivered and/or services performed, and by documents submitted pursuant, and upon fulfillment of other obligations stipulated in these Terms of Reference.
- Payments shall be made promptly by the AMLC within thirty (30) days from issuance of the IAR by the IAC.
- The currency in which payment is to be made shall be in Philippine Pesos.
- The payment of contingency shall be based on actual consumption. The unutilized portion of the contingency fund shall not be released and will revert to the AMLC funds.

### *Warranty:*

- The Supplier warrants that the goods supplied is fit for the use for which it was intended.

- The Supplier warrants it has, and, at all time during the term of the service, will maintain the requisite personnel, competence, skill and resources necessary to provide the required services under these Terms of Reference. The Supplier also warrant that the services shall be performed in a workmanlike manner and in compliance with all applicable laws and regulations. The Supplier further warrants the availability of service and that the services rendered is fit for the use for which it was intended.
- The AMLC shall promptly notify the Supplier in writing of any claims arising under the warranty. Upon receipt of such notice, the Supplier shall immediately and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the AMLC. If the Supplier, having been notified, fails to remedy the defects within the period specified in the contract, the AMLC may proceed to call upon the warranty security, without prejudice to any other rights which it may have against the Supplier under these Terms of Reference and under the applicable law.
