INVITATION TO BID FOR SIEM MAINTENANCE

- 1. The Anti-Money Laundering Council, through the Maintenance and Other Operating Expense Fund intends to apply the sum of PhP 1,586,769.75 being the Approved Budget for the Contract (ABC) to payments under the contract for Security Information and Event Management (SIEM) Maintenance. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Anti-Money Laundering Council now invites bids for SIEM Maintenance. Delivery of the Goods is required 30 calendar days after receipt of Notice to Proceed. Bidders should have completed, within two years from the date of submission and receipt of bids, a contract similar to the Project.
