II. DISCUSSION

Pre-Bid Conference	UAS representative asked for clarification re Income			
PR21-026: Firewall	Tax Returns (ITR) to be submitted to AMLC for post			
Technology Update,	qualification. The BAC responded that the latest ITR			
ABC = PhP5,504,000.00	must be submitted. Considering that April 15, 2021			
	is the deadline for the filing of 2020 ITR, the bidders			
	should submit the 2020 ITR.			
	The BAC will issue bid bulletin amending the			
	required ITR to be submitted to AMLC from 2019 ITR to 2020 ITR.			
	UAS representative asked for clarification if it would			
	be possible to submit Certified Associate in Project			
	Management (CAPM) certificate of one of UAS			
	project managers (PMs) but the assigned PM for			
	Firewall Technology Update Project is different. The			
	end-user responded that the UAS may submit			
	CAPM certificate of both PMs.			
	UAS representative asked for clarification if it would			
	be possible to submit the project RAM and other			
	project documentations like admin guide after the			
	project implementation. The end-user responded			
	that the winning bidder may submit the project			
	documentations after project completion.			
	However, the end-user emphasized that the project			
	manager is required to submit progress report			
	during the project implementation.			
	 Nexus representative asked for clarification re any use case for SDWAN solutions indicated in the 			
	Specifications (Section 7, Item A5). The end-user			
	responded that the main requirement is for load			
	balancing and high availability to maximize the 2			
	Internet Service Providers (ISP). The end-user added			
	that it is also to maximize the use of leased lines.			
	i-Connect representative asked should they have			
	other questions, can they write a letter, until when,			
	including the response. The BAC responded that			
	request for clarifications from bidders must be in			
	writing and may be sent electronically to the BAC on			
	or before 22 May 2021. The bid bulletin will be			
	posted on or before May 25, 2021.			
	Nexus representative asked for clarification re			
	electronic submission of bids. The BAC responded			
	that bids must be duly received by the BAC			
	Secretariat through manual submission (hard copy).			
	UAS representative asked for clarification re			
	transceivers. The end-user responded that the			
	supplier shall provide transceivers and other			
	components that are required to meet the			
	objectives of the project. For transceivers, the end-			
	user clarified that 10G would be enough.
